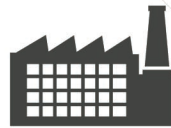

FZCO

This registration is a Limited Liability Company within the Free Zone that allows a multiple shareholder (can be individual or corporate).

FZE

This registration is a Limited Liability Company within the Free Zone that allows a single shareholder (can be individual or corporate).

BRANCH

A branch is a legal entity which already exists outside of the JAFZA Free Zone (local or international).
