

#### LIMITED LIABILITY COMPANY (LLC)

This registration is a Limited Liability Company within the Free Zone that allows a multiple shareholders (can be individual or corporate).

#### **BRANCH**

A branch is a legal entity which already exists outside of the KIZAD Free Zone (local or international)

## **OWNERSHIP**


KIZAD is the first industrial zone in the region that offers dual-licensing, that is, both Free Zone and Non Free Zone licenses. Company formation in KIZAD allows to obtain on-shore branch licenses from the Abu Dhabi Department of Economic Development, without the need for a local sponsor and office space.

This allows companies to take advantages of the benefits offered by free zone licensing, as well as cater to the Abu Dhabi market, and the UAE market in general.
